In a reciprocal arrangement, TCFR members also had access to selected online programs offered by the Phoenix Committee on Foreign Relations, for an additional fee.

### **Looking Ahead to 2021 - 2022**

Each year we try to build the TCFR season around the specific interests of our members, as reflected in the member topic survey distributed in the spring. Next season will be no exception. The topics that drew the most interest in this spring's survey were (I) climate change, (ii) balancing confrontation and cooperation with China, (iii) border security and immigration policy, (iv) Middle East policy, and (v) restoring media credibility. Factors such as availability of quality speakers and unanticipated world events also play a part in constructing the program year.

Quality speakers must be recruited and scheduled several months in advance. To deal with that requirement in the face of continuing uncertainty about the pandemic, the board has adopted a tentative plan for the 2021-2022 season. Our September through December events will be held on the Zoom platform, as were all of our events in the previous season. If all goes well, we will celebrate our return to in-person events with a New Year's luncheon at the Arizona Inn in early January and continue the season thereafter with in-person events.

The executive board will consider this tentative plan further at its September board meeting. Stay tuned.

# **New TCFR Officer and Board Appointments**

Robert L. Thompson assumed the presidency of TCFR on June 1, 2021. Bob has been on the TCFR board since 2014 and was TCFR president from June 2016 through May 2019. He is a lawyer (New York) and a former executive with a multinational company, for which he served several years in overseas assignments.

**N.B.:** Unlike our normal dinner and luncheon events, members were not charged for the Zoom events in 2020-21. Thus, there was no program revenue (and no commensurate payments to event venues). There was, however, a small amount of expense associated with production of the Zoom events. By using remote Zoom presentations throughout the year, we were able to recruit some speakers we would otherwise have been unable to attract. In a departure from our normal practice, in some cases we agreed to pay honoraria for such speakers, in an amount approximating the travel and lodging expenses we saved as a result of the remote presentations.
