Dear Members and Friends of TCFR:

The last time TCFR held an in-person event was March 3, 2020. Since then Zoom has literally saved TCFR's life. Since March 2020 there have been 18 programs and 19 board meetings, all held online. We've temporarily lost some of the collegiality of in-person events, but we've heard from some speakers we wouldn't otherwise have been able to bring to Tucson. Most important, you have stayed with us. Our membership has dropped a bit, but less than we thought it might. Participation in the online events has been strong. You've shown that you value the opportunity, however it's presented, to go deeper into important international relations issues than does daily news coverage. Thank you for your loyalty to TCFR.

We are planning a return to in-person events in the 2022-2023 season. It will be the same TCFR as in pre-pandemic days . . . but different. We expect to present a mix of inperson events and online events. The former will predominate, but we'll occasionally take advantage of the opportunities presented by online events. We might experiment with other formats and venues, as well. We anticipate that meal costs for dinner and lunch events will increase. TCFR meal charges are a pass-through; we charge you what the venue charges us (and we negotiate hard to keep the cost down). We were struggling to keep those charges from rising before the pandemic, so we might be forced to give ground in the coming season. A couple of Zoom events would help to offset higher food prices and keep your overall cost for the season under control. After more than two years of riding the Covid roller coaster it's probably not necessary to say it, but all plans are subject to change, depending on the trajectory of the virus.

This is the first communication coming to you from Tucson Committee on Foreign Relations, **Inc.** Since its founding in 1965 TCFR has been an unincorporated association. A few days ago, on July 1, 2022, to be exact, TCFR began operating as a corporate entity. The corporate form provides greater legal protections to TCFR and its members and is consistent with the organization of most enterprises similar to TCFR. We are now an Arizona nonprofit corporation; we continue to have 501(c)(3) federal tax-exempt status, so donations to TCFR are still tax-deductible as provided by law. You won't notice any change as a result of this development other than an "Inc." popping up from time to time, but it is a significant step forward, made possible by many hours of volunteer work by the TCFR board.

Thank you again for being a member of TCFR. We look forward to seeing you at TCFR events next season.

Dr. Gary Guertner Steps Down as Vice President, Program

After eleven years of planning programs, recruiting speakers, and worrying about flights delayed by snowstorms, Gary Guertner has stepped down from the post of TCFR's VP of programs. Fortunately, he will remain on the Board of Directors and on the Program Committee to assist in the transition to his successor, Bill Banks.

Gary brought to his TCFR role a strong background in national security, starting with his service as a Marine Corps lieutenant and captain in combat in Vietnam. He earned a Ph.D. after leaving the Marine Corps and, following a stint as professor of international relations at California State University, Fullerton, Gary became Professor of Strategy at the U.S. Army War College. Eventually he was named chairman of the Policy and Strategy Department, the first civilian to be appointed a department head at the War

College. Gary later served as dean of the College of International and Security Studies at the George Marshall Center for European Security Studies at Garmisch, Germany.

TCFR is indebted to Gary for his dedication and creativity and for the success TCFR enjoyed during his tenure as a result of the excellent programs for which he was primarily responsible.

New TCFR Officer and Board Appointments

Thomas Volgy assumed the presidency of TCFR on June 1, 2022. Tom was TCFR president from June 2019 through May 2021, then took a break that coincided with a sabbatical from his duties at the University of Arizona, where he is professor of political science in the School of Government and Public Policy. He is a former member of the Tucson city council and a former mayor of Tucson.

William Banks became Vice President, Program, on June 1, 2022. Bill is professor of law emeritus and a former dean of Syracuse University College of Law. He also served as special counsel to the U.S. Senate Judiciary Committee (chaired then by Senator Joe Biden), among other public service appointments

Christine Wells, Christine Shea, and Cody Nicholls continue in the positions of, respectively, vice president, treasurer, and secretary.

David Metzner joined the board on June 1, 2022. David is a physician who practiced in Cambridge, Massachusetts; New Orleans, Louisiana; and Bennington, Vermont. He served as a physician in the U.S. Air Force during the Vietnam conflict, with the rank of major. David replaces Elliott Weiss who has resigned from the board after a decade of service and many significant contributions.

Want to Advance TCFR's Mission? You Don't Have to Be a Foreign Policy Expert to Serve on the Board or a Committee

TCFR is a volunteer-run organization without paid staff. Although our "product" is educational programs concerning International relations and foreign policy, we need a wide range of skills and backgrounds on the board and board committees. It is not necessary to be a board member to serve on a committee. These committee opportunities are open to any TCFR member:

Communications & Marketing: Marketing strategies and materials, media relations and publicity, website content, communications with members. Backgrounds in marketing, writing and editing, design, media, photography are all helpful.

Events: Logistics related to events—negotiate arrangements with venues, menu selection, assist with care and feeding of speakers, staffing of event reception desk, primary host for Zoom events.

Finance & Governance: Oversee finance function, risk management and insurance, tax returns and government reports, corporate governance. A good landing spot for finance and accounting professionals, lawyers, and paralegals.

Membership: Maintain membership records by membership category, report membership totals to the board monthly, monitor non-renewing members for follow-up, monitor guest attendance at events.

Nominating: Identify, interview, and nominate candidates for board of directors; nominate candidates for officer positions.

Program: Selection of topics (including member survey), recruitment of speakers, preparation of event announcements and speaker bios, liaise with speakers concerning travel and lodging arrangements, care and feeding of speakers while in Tucson, introduce speakers at events, conduct Q&A. This is a committee for which background and contacts in the field of foreign affairs are helpful.

Technology: Member management software transactions (applications for membership and dues payments, event registrations and payments, donations, all-member communications), set-up and operation of sound system, maintenance of up-to-date website, back-up host for Zoom events.
